- All event rates include set-up and take-down of tables and chairs plus a four (4) hour maximum decorating window.
- The deposit is refundable within thirty (30) days after the event per the contract clause(s).
- If the event is canceled sixty (60) days before the event, the deposit will be returned.
- Security is required for all events except for three (3) hour events between 10:00 am – 4:00pm, Monday–Thursday.

Pre-Event Activities	<ul style="list-style-type: none"> ▪ \$75 per hour for <u>any</u> amount of time over a total of four (4) hours. ▪ \$25 per hour if ANY lights or the air conditioning are left on after the facility is vacated. 	
Set Up	<ul style="list-style-type: none"> ▪ An additional fee of \$100 will be charged for table/chair/umbrella set up on the Patio. ▪ If any changes to room or patio setup are requested after it has been completed per the original agreement, a <u>minimum</u> \$25 per hour fee will be assessed for the changes. 	
Overtime	If any event type noted above goes over the hours agreed to in the <i>Contract</i> , an Overtime Fee of \$200 per extra hour or portion thereof will be assessed.	
Additional	Additional charges may apply: <ul style="list-style-type: none"> ▪ Depending upon the event and, if applicable, will be noted in the <i>Contract</i>. ▪ Be assessed <u>after</u> the event as noted above or if extensive damage occurs or additional cleanup is required. Additional charges will be deducted from the deposit.
